SPECIAL MEETING MINUTES APPROVAL

TREASURER CHANGEOVER

MAY 23RD 2025

The special meeting was called to order at 6:00 p.m. followed by the Pledge of Allegiance and roll call.

COUNCIL MEMBERS' PRESENT: R. Huizar, T Tait, D. Meyer, T. Nusz, M. Strasz EMPLOYEES PRESENT: C. Wilson, S. Bills

Motion by T. Nusz to approve the Akron Council meeting minutes for May 20th, 2025, with a correction to the burn ban wording, T. Tait supported the motion. All in favor with 5 Yays and 0 Nays. Motion carried.

Motion by D. Meyer to approve the Akron Special Council meeting minutes for May 19th, 2025, T. Nusz supported the motion. All in favor with 5 Yays and 0 Nays. Motion carried.

Motion by M. Strasz to apply the delinquent utilities to the Summer 2025 tax roll, T. Nusz supported the motion. All in favor with 5 Yays and 0 Nays. Motion carried.

Motion by T. Nusz to eliminate the custodial position at the Village of Akron, M. Strasz supported the motion. All in favor with 5 Yays and 0 Nays. Motion carried.

R. Huizar said we are having an issue with the custodian coming in and punching in for 3-4 minutes and just dumping trash and we are paying that person for ¼ hour of work time. R. Huizar at the end of a month that adds up to a lot of unused minutes. D. Meyer adds that if we have someone willing to do it for free, then it makes sense to eliminate the position.

The motion by D. Meyer to terminate Lisa Hill from her position in the police department of Akron, T. Tait, supported the motion. All in favor with 5 Yays and o Nays. Motion carried.

It was noted that the new police chief David Danielson stated that L. Hill will not be necessary to employ because J. Holsapple and himself can do the work that she does.

Motion by M. Strasz to allow the treasurer to take the Village owned laptop home to perform all job duties, T. Tait supported the motion. All in favor with 5 Yays and o Nays. Motion carried.

D. Meyer stated that the treasurer can work remotely from home with the laptop to be able to perform all job duties and also needs to come down to the meetings once a month.

Kay Vollmar left the meeting, D. Meyer asked if we thanked her for her service, R. Huizar said she thanked her for the help that she gave us during a difficult transition of treasurer changeover.

Motion by M. Strasz to send Kemps tiling the bill for the Cooper repair street fix on Beach Street. Kemps fixed it in December of 2024. D. Meyer supported the motion. All in favor 5 Yays and o Nays. Motion carried.

Motion by T. Tait to purchase a new John Deere lawn mower for the DPW, A JDZ970R in the amount of \$9,952.39 from Tri County Equipment. Motion supported by D. Meyer. All in favor with 5 Yays and 0 Nays. Motion carried.

In discussion the council tabled the Monchilov manhole fix on Lynn St pending another quote.

R. Huizar asked S. Bills to pick up the barrels blocking Lynn St by the bar and near Center St because that is a village street and there is no reason to have it blocked off.

The sidewalks were also discussed, if it was the homeowner's responsibility to keep those sidewalks clean in the winter. Also, if there was something out there that the DPW could get to clean those sidewalks. The council agreed that only about ½ the people in town would clean their sidewalks and once we start doing it, they would expect us to keep them clean and maintained all winter.
